



Manufacturers Declaration for Consignment

Dear Aviation security and/or Gateway Facility,

Notification regarding this consignment

We hereby declare that everything in this package can be shipped by aircraft without any regulations, in accordance with the **IATA 57th edition chapter 3.9.2.2** and **Packing Instruction PI 953** which applies to **UN 2807; magnetised material on passenger and cargo aircraft where should accept:**

1. Permanent magnets, where possible, have keeper bars installed.
2. The magnetic field strength at a distance of 4.6m (15ft) from any point on the surface of the assembled consignment:
 - Does not exceed 0.418 A/m (0.00525 gauss), or
 - Produces a magnetic compass deflection of 2 degrees or less.
3. Devices such as magnetrons and light meters have been packed so that the polarities of the individual units oppose one another.

This package and goods contained within also **meet** the international couriers' guidelines for dangerous goods as described by **D2.9.2–Magnetised Materials** and complies with;

- Australia Post/International couriers Terms & Conditions Part D – Prohibited Goods.
The goods have been packed in accordance with Appendix 3.
- DHL Freight Terms and Conditions Section 7 – Dangerous Goods
The goods have been packed in a safe and contained manner in accordance with Class 9 requirements.
- FedEx Conditions of Carriage Section 12.8 – Dangerous Goods Packaging Requirements
The goods have been packed in a safe and contained manner in accordance with Class 9 requirements.
These goods are not assessed a surcharge under UN 2807 – Conditions of carriage, section 12.4

We declare that the package has been tested with a gauss meter and comply with the guidelines and that when packaged, are **not classified as dangerous goods** as described Australian Civil Aviation Act 1988 and [Civil Aviation Regulations](#) and also by [Australia Post Guidelines](#) in that the magnet material, when packed, has a magnetic flux density less than 0.159 A/m at a distance of 2.1 metres from any point on the surface of the package.

Not classified as hazardous goods as understood in the ordinance given magnetised parts in packaging units.
